Executive Summary. As a result of the investigation, OES concludes that: FIGG Bridge Engineers (FIGG), the Engineer of Record (EOR), failed to recognize that the bridge was in danger of collapsing when it inspected it hours before the collapse. The concrete truss had developed numerous wide and deep structural cracks jeopardizing the integrity of the bridge.

Final Collapse Report Details Miami Bridge Team's Failures ...

In June 2019, OSHA released its final report on the FIU bridge collapse and concluded FIGG Bridge Engineers failed to recognize collapse was imminent when they inspected the bridge hours earlier. They also concluded the bridge had structural design deficiencies, severe cracks were wrongly ignored by the Engineer of Record and warranted street closure, and contract bridge design experts violated basic FDOT construction requirements.

NIST issued its final report on the collapse of the World Trade Center Twin Towers in September 2005. It issued its final report on 7 World Trade Center in November 2008. NIST concluded that the collapse of each tower resulted from the combined effects of airplane impact damage, widespread fireproofing dislodgment, and the fires that ensued.
