Covered Entity: an entity that is subject to HIPAA because it performs certain health care functions. The City is a covered entity for HIPAA compliance purposes. Because the City is a hybrid entity, only those departments, divisions, units, and workforce members within the City's designated health care component are subject to HIPAA requirements.
