Itin Application Supporting Documents

IRS streamlined the number of documents the agency accepts as proof of identity and foreign status to obtain an ITIN. There are 13 acceptable documents. Each document must be current and contain an expiration date. IRS will accept documents issued within 12 months of the application if no expiration date is normally available.

What documentation is required for the ITIN application? If you plan to submit copies of ITIN documents, you need to

make sure they are certified copies. Certified copies are provided directly from the issuing agency that made your original document. The issuing agency will provide a stamped certification seal proving that the copy is accurate.

To begin the ITIN application process, you will need to bring: A complete IRS Form W-7. A U.S. federal income tax return. Your Passport or TWO (2) of the following documents: (including at least one identification with photo and one identification from your country): ...

If a passport is not being submitted along with the application, then at least two supporting documents must be submitted with the application. Supporting documents must also be submitted for dependents if the passport doesn't include a date of entry into the

Individual Taxpayer Identification Number (ITIN) is a tax processing number issued by the Internal Revenue Service to Non-US citizens to be used on federal tax documents to file taxes. You need an ITIN to file your taxes when you don't have a Social Security Number (SSN).

When you apply for an ITIN, you'll usually submit several kinds of supporting documentation along with your Internal Revenue Service W-7 form. Many people prefer to submit original passports or certified copies, as it satisfies both requirements to prove one's identity and foreign status.

The only single stand-alone documentation that proves both foreign status and identity is a passport. You must submit either a passport or any two of the documents below in order to prove both your identity and foreign status.

one that the taxpayer provides to a public notary who bears witness to the signing of the official document and affixes a seal assuring that the document is legitimate. These documents will not be accepted for ITIN applications.

ITIN application, you may wish to apply in person at an IRS Taxpayer Assistance Center or CAA. You may also choose to submit certified copies of documents from the issuing agency instead of original documents. Original documents you submit will be returned to you at the mailing address shown on your Form W-7.

Listed below are the only documents that will be accepted by the IRS. An "X" in the Foreign Status and/or Identity column, indicates that the supporting documentation satisfies that category. A valid (unexpired) passport is the only stand-alone document to prove both identity and foreign status.

How do I apply for an ITIN? Use the latest revision of Form W-7, Application for IRS Individual Taxpayer Identification Number to apply. Attach a valid federal income tax return, unless you qualify for an exception, and include your original proof of identity or copies certified by
