Landlord Tenant Rights In Florida

A tenant must notify the landlord, in writing, by hand delivery or mail, of noncompliance with Florida law or the requirements of the rental agreement. The written notice shall also indicate the tenant's intention to terminate the rental agreement due to this noncompliance.

A tenant has certain rights and responsibilities under Florida law. These are specified in the Florida Statutes at Part II, Chapter 83, the Florida Residential Landlord Tenant Act. A tenant in federally subsidized rental housing has rights under federal law, as well. If there is no written lease, these laws regulate the tenant's rights.

If a written or oral lease exists or if a landlord has previously accepted payment as rent, a renter has inherent rights under Florida landlord tenant law (FL Statute Chapter 83). These include the right to a habitable premises, due process before an eviction and more.

For the most part, Florida's state government has made a firm effort towards making their landlord-tenant laws accessible and actionable. In fact, the majority of pertinent information on this topic can be found in the Florida Statues, chapter 83, part II. Florida Renter's Rights for Repairs & Living Conditions [2020]

A landlord MAY NOT evict you solely in retaliation for the tenant complaining to a governmental agency about code violations or asserting other tenant rights. Non-Payment of Rent Section 83.56(3), F.S. The landlord must serve you, the tenant, a written notice allowing three days (excluding weekends and legal holidays) for you to pay

Florida's Landlord/Tenant Law - Florida Department of ...

The provisions of ss. 83.801-83.809 shall be in addition to all other rights allowed by law in a creditor-debtor or landlord-tenant relationship. (2) Chapter 82-151, Laws of Florida, shall apply to all rental agreements entered into, extended, or renewed after July 1, 1982.

Florida law also gives the residential tenant rights in defending against any lawsuit filed by the landlord. The tenant, for instance, has five days (where the landlord asks for possession or asks to evict the tenant) to twenty days (where the landlord asks for rent damages) to file an answer to the complaint.

Florida law stipulates that tenants must pay rent and do so on time, based on the terms of the lease. In Ginn's experience, nonpayment of rent is the leading cause for landlords in Florida to pursue eviction.
