A common problem caused by incorrect use of pronouns is an improper pronoun agreement, also referred to as a pronoun/antecedent agreement. This is meaning that all pronouns used in any sentence must always be matching the object or subject they replace.

Because everyone is singular, their is the wrong pronoun. The pronoun that is impersonal, but of course, David is a person. The antecedent of a definite pronoun should be clear, not ambiguous.
