You MUST STOP at least ten (10) feet away from the school bus. You MUST WAIT until the red lights have stopped flashing and the stop arm has been withdrawn before moving. DO NOT MOVE until all the children have reached a place of safety.

PENNSYLVANIA'S SCHOOL BUS STOPPING LAW

The Laws of Pennsylvania, also referred to as the Pamphlet Laws, have been recognized as official law since December 1, 1801. Acts are numbered by the Department of State and published by the Legislative Reference Bureau as separate official documents known as slip laws before publication in bound editions as the Laws of Pennsylvania.

PA Homeschool Law - How to Comply With Pennsylvania ...

Pennsylvania Law prohibits the use of the 11-15 passenger vans for the transportation of school students (unless it was a vehicle that was grandfathered). In fact, Federal Law, 49 U.S.C Section 30112 (a) prohibits the selling, buying, or leasing of a vehicle in this category if it is to be used to transport school students.

Pennsylvania law requires charter schools to be open to all students in the state, but requires them to give first preference to students who reside in the sponsoring school district or districts. The law states that a charter school shall not unlawfully discriminate in admissions, hiring or operation.

Pennsylvania Education Laws - FindLaw

All children between the ages of 8 and 16 are required to attend school under Pennsylvania's compulsory education requirements. Families choosing home education to fulfill those requirements must: Be taught by a parent (or legal guardian) with a high school diploma (or equivalent) who has not

been convicted of any major criminal offenses in the previous five years.

---

#### PENNSYLVANIA'S NEW TRUANCY LAW

When the Pennsylvania homeschool law was amended in 2014, it identified limited circumstances and a precise procedure that a superintendent is required to follow to contact a supervisor of a home education program.

#### Pennsylvania Homeschooling Laws - Home School Legal in PA ...

Children must attend school or comply with the homeschool laws between the ages of 8 and 17 years. At the start of the 2020-2021 school year, those ages will be from between 6 and 18 years, with students who graduate being exempt. Philadelphia's compulsory school age is 6.

#### Pennsylvania Homeschool Law - HSLDA

Pennsylvania law prohibits children from standing on the bus while the bus is in motion. Check to make sure all of the children unloading from the bus are at a place of safety before deactivating your eight-way light system and moving the school bus.

#### PA General Assembly

The law expressly requires schools to notify parents or guardians in writing within ten (10) school days of the child's third unexcused absence that the child has been "truant." This notice:
