Police misconduct can involve any actions by staff and employees of the Colorado police force that are unethical, illegal, or in violation of your rights under the U.S. Constitution. However, law enforcement officers have some "qualified immunity" that protects them from civil lawsuits as long as they do not invade the victim's rights.

Under Colorado law, Prosecutorial misconduct occurs when the district attorneys or attorneys general engage in some kind of wrongdoing -- or even illegal action -- during the prosecution of a criminal case. Prosecutors in Colorado are expected to conduct themselves under a high standard of conduct, but often prosecutors go too far to try to get a conviction.
