Chiropractic Laws and Regulations - Parker University

A licensed chiropractor not engaged in chiropractic practice as an individual practitioner, a partner or a partnership, a shareholder of a professional service corporation, as an employee of such practice units, or as an employee of a facility operating pursuant to article twentyeight of the public health law, or as otherwise determined by the department, shall be exempt from the mandatory continuing education requirement upon the filing of a statement with the department declaring such status.

Regulation - British Chiropractic Association

Chiropractors were jailed for "practicing medicine without a license" which the profession designed a legal and political defence against prosecution arguing that chiropractic was "separate and distinct from medicine", asserting that chiropractors "analyzed" rather than "diagnosed", and "adjusted" subluxations rather than "treated" disease.

Compensation for Chiropractic Care in Personal Injury ...

In addition to the professional education requirement, every applicant for licensure as a chiropractor must complete coursework or training in the identification and reporting of child abuse in accordance with Section 6507(3)(a) of the Education Law.

NYS Chiropractic License Requirements

Administrative Rules pertaining to chiropractic practice are written and adopted by the Board of Chiropractors. The Board writes rules in order to administer the laws over which the Legislature has given the Board authority. Rules can be changed by going through the rule-making procedure. They do not go through the Legislative process.

If you have never been to a chiropractor before, chances are that you will first seek more traditional treatment from medical doctors and physical therapists before pursuing chiropractic care. Whether you are covered by an automobile insurance policy or a general health insurance policy, your claims for chiropractic care may be limited by policy provisions that limit the number of approved visits.

Good Chiropractors and Bad Chiropractors - Michigan Auto Law

In common with other healthcare professionals such as medical practitioners nurses and dentists, the chiropractic profession is regulated by law. The Chiropractors Act 1994 provides statutory regulation for the profession and the title 'chiropractor' is protected under this legislation.

The California Board of Chiropractic Examiners mission is to protect Californians from fraudulent or incompetent practice of chiropractic, examine applicants for licensure in order to evaluate entry level competence, and enforce the Chiropractic Initiative Act and regulations relating to the practice of chiropractic.

Board Laws and Regulations

D.D. Palmer defined chiropractic as "a science of healing without drugs" and considered establishing chiropractic as a religion as a means to use religious "exemption clauses" to resolve legal difficulties presented by restrictive "chiro laws". In 1911, he stated (emphasis in original):

Washington Administrative Code (WAC) A rule or Washington Administrative Code (WAC) is written to provide interpretive support for the individuals or entities to whom the rule applies.
